- Theme
 - The council agreed on naming the theme "Breaking Barriers and Empowering Change" for this year's conference.
- Breakout Sessions
 - Dani mentioned a class on finding inner peace and quieting the outside noise. It was mentioned to have different generations with and without kids within the workforce explain what their noise looks like and how they quiet it. This could be good for the panel to discuss. Anna mentioned having a Wall Fellows student that is about to graduate college and heading into the workforce to represent that generation. Dr. Jessica Greene mentioned having a class on explaining the difference between mentors and sponsors. Another good class could be on branding yourself to the workforce. We believe three breakout classes are enough for the conference. The council agreed to invite Shelbia Wiley back to do her class, since she was unable to teach it last year.

We also mentioned Simone Biles, Shawn Johnson USA elite gymnasts, Joan Lundon ABC's Good Morning America co-host, Ginger Zee chief meteorologist for ABC News, Tori Stevens CEO of evolYOUtion Career Coaching and the founder of IT Cosmetics Jamie Kern Lima.
 - Other
 - The DJ was very good, and everyone liked that there were vendors at the conference. The bookstore owners agreed they will be back for this year and had a great experience. The council mentioned having more boutique vendors. Tidelands Health has agreed to be our presenting sponsor again. We also received a \$7,500 Silver sponsorship from BlueCross and Blue Shield. A few survey responses mentioned diversity in the room and assisting with that. We are going to create an invite in Spanish and reach

out to our list of diverse businesses we have in our database and personally invite them. Dani mentioned potentially giving away tickets for individuals who may not be able to afford it. Cindy said that we could either have a sponsor pay for the free tickets we would provide or have a raffle. Amanda mentioned we could also reach out to diverse businesses about being a vendor at our conference. Kema said she could speak with Renee Wright to get a list of vendors from her event that is targeted towards the diverse community. We could also send a personal invite to Clevel individuals using our CEO list to hopefully get more of them in the room, as well as mentioning the event at our CEO Roundtables and encouraging them to attend the conference. Anna mentioned having a celebration wall at the conference where people could write what they accomplished this year on a sticky note and put it on the wall and take a photo with it, possibly with the 360-photo booth to get more attention to it. Someone mentioned requesting Tidelands Health have something that is more targeted towards women's health specifically.
